ARTICLE I. IN GENERAL

Sec. 26-1. Elected officials.

- (a) *Officers.* The elective officers of the city shall be a mayor and nine alderpersons.
- (b) *Alderspersons.* The nine alderpersons shall be comprised of two from each of the three aldermanic districts and three at large, with each of the nine alderpersons serving a three-year term. The three alderpersons at large shall be elected in one year, in the spring election. Of the two alderpersons from each aldermanic district, one representing each aldermanic district shall be elected each year, for two consecutive years, in the spring election.

Sec. 26-2. Taking office.

The regular terms of the mayor and the councilmembers shall commence on the third Tuesday in April following their election. The regular terms of all other elected or appointed officials shall commence on May 1, following their election or appointment, unless otherwise provided.

Sec. 26-3. Polling place.

The polling place or voting poll of the city shall be in the Brillion Community Center located at 120 Center Street.

ARTICLE II. WARDS*

Sec. 26-31. Boundaries.

The boundaries of the aldermanic districts are as follows:

- (1) *District No. 1.* All territory within the city north of the centerline of Wolfschmidt Street extended easterly to intersection of Elm Street and east of the centerline of Elm Street extended southerly to intersection of Washington Street and north of the centerline of Washington Street extended easterly to the intersection of S. Main Street and west of the centerline of S. Main Street extended northerly to the intersection of Park Avenue and north of the centerline of Park Avenue extended easterly to the intersection of N. Francis Street and west of the centerline of N. Francis Street extended northerly to the intersection of USH 10 and north of the centerline of USH 10 extended easterly to the east boundary limits of the city.
- (2) *District No. 2.* All territory within the city south of the centerline of Wolfschmidt Street extended easterly to the intersection of Elm Street and west of the centerline of Elm Street extended southerly to the intersection of Washington Street and south of the centerline of Washington Street extended easterly to the intersection of S. Main Street and west of the centerline of S. Main Street extended southerly to the intersection of National Avenue and south of the centerline of National Avenue extended easterly to the east boundary limits of the city.
- (3) *District No. 3.* All territory within the city south of the centerline of USH 10 extended westerly to the intersection of N. Francis Street and east of the centerline of N. Francis Street extended south to the intersection of Park Avenue and south of the centerline of Park Avenue extended west to the intersection of S. Main Street and east of the centerline of S. Main Street extended southerly to the intersection of National Avenue and north of the centerline of National Avenue extended easterly to the east boundary limits of the city.
