## A. Community Center:

## 1. Facility Report:

The Commission reviewed the monthly usage comparison for October 2016 and the numbers are up 30 from 2015.

### 2. Fencing-New Bids:

The Commission reviewed the bids for fixing the fence around the BCC. Fortress Fencing had the best bid for \$1,330.00 to fix the north side of fencing. The fencing will be fixed by years end. The east side fencing will be looked at in 2017 when money should be available in reserves

## 3. 2017 Budget, Capital and Reserve - Update:

The Commission reviewed the budget as it will be presented to the Council and the overall budget is in line with past years. Marx distributed the Capital and Reserve and pointed out the majority of projects that money was requested for have been cut and the projects that will be asked for approval with budget are highlighted in yellow. Marx mentioned that there may be a need to borrow in order to get some of the projects completed.

The Commission did prioritize the first three areas they would like to see worked on:

Roof of Youth Center

Ceiling Tiles of Youth Center

New Flooring, which could be done in phases

# 4. New Silver and Fit Program:

The Commission had been researching ways to block off the main pool from the Splash Pad and locker rooms when the pool is not open. A curtain was decided upon which will be installed under the balcony viewing area. The BCC had planned to pay for the curtain but the Optimist was able include the curtain in the project.
