A. Parks

1. Park Bathroom Hours:

Miller had a concern with the round-up being used in the parks. Miller stated that a motion was made last year that the Park Board needs to give approval for the use of roundup in the parks.

The Commission reviewed the numbers. Marx stated that there are no numbers for the front door counter because it stopped working. The counter from the back door has been moved to the front doors and Marx is looking at getting a new counter for the back door.

Marx handed out a list of possible items to include in the 2019 budget. One item that needs to be addressed is the money for the ash trees in the parks. As stated before if DPW can drop the trees in winter and rock the block volunteers can cut them up in spring then volunteers can clean up the park and add mulch and grass seed.
