**PLAN COMMISSION

CALL TO ORDER: Mayor Gary Deiter called the meeting to order at 6:00 P.M.

ROLL CALL: Present were Mayor Gary Deiter, Robert Mathiebe, Al Ebert (arriving at 6:03 PM), Zane Zander, Gerald Sonnabend, Garrett Zimpel, and Alderperson Crystal Fhlug. Also present were City Administrator/Clerk-Treasurer Lori Gosz, Community Development Director Justin Linzmeier, and Building Inspector Mike Angoli.

APPROVAL OF THE AGENDA:

Motion – Sonnabend moved to approve the agenda. Seconded by Zander. Motion carried unanimously.

APPROVAL OF THE JUNE 2, 2014 MINUTES:

Motion – Mathiebe moved to approve the minutes of the June 2, 2014 Plan Commission meeting minutes. Seconded by Fhlug. Motion was carried unanimously.

BRILLION COMMUNITY CHURCH – CEMETERY PROPOSAL AND REZONING REQUEST:

Angoli reported the Church is requesting that the entire parcel be rezoned to Institutional.

Motion – Sonnabend moved to recommend to City Council the rezoning request from the Brillion Community Church to rezone Parcel ID#15368 from A-1 (Agricultural) to ID (Institutional). Seconded by Mathiebe. Motion carried.

RANDY’S CENTRAL – FISH BOIL PERMIT REQUEST:

Angoli reported Randy’s Central would like to have a fish boil. The State Fire Code requires 50’ from a commercial building. Angoli is researching to see what other communities do, but cannot find any samples. Angoli is concerned with the close proximity to other properties.

Angoli explained Randy’s Central would like to do this on July 12th. He would like to allow this one (1) time event until the Plan Commission can review it further.

Angoli is requiring that everything be cleaned up after the event and the fire is always attended and extinguished once done. Angoli has notified the Police Department if there is an issue it will be shut down.

The Commission agreed to give this a one (1) time chance.

Motion – Mathiebe moved to allow this one (1) time request as regulated by the Building Inspector/Zoning Administrator. Seconded by Ebert. Motion carried.
